Subject:- Release of matching State Share Rs. 3.00 crore under Capex Budget 2018-19 for CSS scheme of "Pollution Abatement of rivers Devika and Tawi at Udhampur under NRCP.

Sanction is hereby accorded to the release of **Rs.3.00 Crore (Rupees Three Crore only)** in favour of Chief Engineer, J&K Urban Environmental Engineering Department (UEED) as matching State share under Capex Budget 2018-19 for CSS scheme of "Pollution Abatement of rivers Devika and Tawi at Udhampur under National River Conservation Plan(NRCP) .

The release & subsequent utilization of funds is subject to the following conditions that:-

- i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- ii) the funds shall be utilized strictly in accordance with the Guidelines of the scheme for the purpose for which it has been sanctioned and as per the terms & conditions of Govt. of India's sanction letter No:- J-27023/ 1/2106—NRCD –II dated: 28-09-2018 & No:- J-27023/1/2016-NRCD-II Dated:- 31-10-2018. ;
- iii) the funds shall be utilized for execution of the scheme strictly as per originally approved components and according to GOI's prescribed guidelines which have been technically sanctioned and administratively approved by the Competent Authority;
- iv) the implementing agency shall ensure that there is no overlapping of funds from any other source including languishing projects funded through JKIDFC and shall not be used for clearing any past liability ;
- v) the funds so released shall not be available for any re-appropriation/diversion;
- vi) the expenditure shall commensurate with the physical progress achieved;

- vii) all video graphic/photographic evidence of works both shall be maintained.
- viii) the physical and financial progress report alongwith Utilization Certificate of the funds released shall be furnished as early as possible and definitely well before 31.3.2019 to GOI, with a copy to Finance Department.


