Sanction is hereby accorded to the release of funds amounting to **Rs. 22.93 Lacs (Rupees Twenty Two Lakh and Ninety Three Thousand) only, in favour of Director, Urban Local Bodies Jammu** for its further placement at the disposal of Executive Engineer Town Drainage Jammu under the scheme "**Emergent Public Demand**" of Capex Budget 2018-19 under Drainage Sector for clearance of work done claims on account of work namely "**Construction/Laying of RCC Slab over Nallah in W.No.8 & 10 near H/o Shehnaz Ganaie Poonch**" during Current Financial Year.

The release & subsequent utilization of funds is subject to the following conditions that;

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the implementing agency shall ensure that there is no overlapping of funds for the works being executed from any other source viz SDRF, District Plan, CSS, BADP, Flagship Programme, CDF, MPLADS etc.;
- (iv) the funds so released shall not be available for any re-appropriation/diversion;
- (v) the expenditure shall commensurate with the physical progress achieved;
- (vi) all video graphic/photographic evidence of works shall be maintained;
- (vii) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- (viii) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.

The expenditure under Centre Share shall be booked under proper classifications as given below:-


