In continuation to Government Order No:-261-HUD of 2013,dated:-26.09.2013,Sanction is hereby accorded to the withdrawal of funds amounting to Rs.5.72 lacs (Rupees Five lacs and Seventy Two Thousand) only out of the Official Account No:-0110040100005976 favouring Vice Chairman J&K State Urban Development Agency only in favour of District Urban Development Agencies of State (DUDAs) as grant-in aid under Poverty Alleviation SJSRY scheme for meeting the Honorarium of Community Organisers and wages to employees working on consolidated basis in various DUDAs of the state thereby raising total releases up to Rs.15.72 lacs during the financial year 2013-14 as per the following details:-

- iv. That there is an act of sanction of competent authority for incurring the formalities.
- v. That the agency shall furnish utilization certificate to this department at the end of financial year 2013-14.
