**However, the release of funds is subject to the following conditions:-**

- i. The release of funds does not confer the sanction to incur the expenditure and shall be booked only after observing all codal formalities.
- ii. The saving if any shall not be re-appropriated towards any other component without the approval of the competent authority,

- iii. The implementing agency shall ensure that there is no overlapping of funds for the cases sanctioned by the financial institutions.
- iv. The expenditure shall commensurate with the physical progress achieved.
- v. The DUDA's shall furnish physical/financial progress report to this department on monthly basis as per the subsidy released to the banks/financial institutions.
- vi. The utilization certificate of the funds so released shall be furnished to this department expeditiously by 31th of March 2014.
- vii. The interest money (if any) accrued on previous funds during the parking in the Bank Account shall not be utilized without the approval of Administrative Department.

**Any deviation in non fulfilment of aforementioned conditions shall be treated as misappropriation of funds.**
