- IV. The payment shall be made in stages only after the completion certificate duly signed by the concerned beneficiary is furnished.
- V. Any addition/ modification if any to be made in type design in view of site condition shall subject to approval of Executive Engineer concerned
- VI. The Director Urban local Bodies Jammu/Kashmir & Commissioner SMC/JMC or their subordinate agencies shall draw necessary agreement with the executing firm/ NGO before the start of work.
- VII. The concerned Corporation/ ULB's shall upload the photographs of the completed IHHL along with beneficiary picture.
- VIII. The concerned Corporation/ ULB's shall provide the list of beneficiaries in those cases where the IHHL's are to be constructed by the approved NGO/ Firms.


