

Constitution of Rajouri as a Notified Area
SRO-398 dated 11th November 1962.

In exercise of the powers conferred by section 283 of the Jammu and Kashmir, Municipal Act, Samvat 2008 (VIII of 2008). The Govt hereby declare that within the Local Area of Rajouri, Tehsil Rajouri, District Rajouri Poonch which is constituted as a Notified Area and the boundaries of which are described in the schedule annexed hereto, improved arrangements are required to be made with respect to the matters upon which Municipal Fund may be expended:-




