

**Constitution of Reasi as a Notified Area**  
**SRO-374 dated:- 30<sup>th</sup> November 1962**

In exercise of the powers conferred by section 283 of the Jammu and Kashmir Municipal Act. 2008 (VIII of 2008). The Govt. hereby declare that within the local area of Reasi Tehsil Reasi , District Udhampur, which is constituted as a Notified Area Committee and the boundaries of which are described in the Schedule annexed hereto, improved arrangements are required to be made with respect to the matters upon which Municipal Fund may be expended:-

**Boundaries:-**

**North:-** Khasra Nos. 173 min, 150 min, 148 min, 147 min, 80 min, 90 min, 83 min, 751,125 and 124 min, 121 min, 120 min of village silla and 1234, 1238,1236 and 1288 of village Mari.

**East:-** Boundary line joining, Trijunctions between Trantha, Suketar and Reasi (and Khasra Nos. 126 of Suketar).

**South:-** Permanent demarcation between Reasi and Dasanu village.

**West:-** Demarcation line between village Silla and Reasi joining the Trijunction with Khasra Nos. 173 min of village Silla.
