SRO <u>41</u> Whereas, the Town Planning Organization, Jammu prepared draft Master Plan, Udhampur, 2031 to extend the Udhampur Local Area and notified the same in terms section 10(1) of Jammu and Kashmir Development Act, 1970 for inviting objections and suggestions from the general public; and

Whereas, vide Government Order No. 234-HUD of 2014 dated 06-08-2014, a Committee was constituted to scrutinize the objections/suggestions received from

the general public; and

Whereas, the Committee after scrutinizing the objections/suggestions received from the general public, political representatives, stake holders furnished its recommendations for Master Plan of Udhampur, 2031; and

Whereas, the Government after having examined the Master Plan Udhampur, 2031 approved the same vide Cabinet Decision No. 36/02/2017 dated 13.02.2017.

Now, therefore in exercise of the powers conferred by section 11 of Jammu and Kashmir Development Act, 1970, the Government hereby notifies that Master Plan of Udhampur, 2031 as approved shall come into operation from the date of issuance of this notification.
