- i. **the implementing agency shall ensure the Physical Verification of work and certify that the work has been executed as per the approved cost estimates before making payments.**
- ii. the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities.

- iii. the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- iv. the funds shall be utilized on the ongoing schemes/works only and no new scheme shall be taken up without the approval of the competent authority;
- v. the funds shall not be utilized on clearance of any past liability, repair renovation & Maintenance work.
- vi. the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- vii. the funds so released shall not be available for any re-appropriation/diversion;
- viii. the expenditure shall commensurate with the physical progress achieved;
- ix. all video graphic/photographic evidence of works both shall be maintained.
- x. the physical and financial progress report shall be furnished to the Admn. Deptt. well in time
- xi. the implementing agency shall follow up the procedural mech. Of CAS – MIS System.
