- i. Academic/Technical Qualification.
 - ii. Matriculation/Date of Birth Certificate.
 - iii. Health Certificate from the concerned Chief Medical Officer of the District.
 - iv. Permanent Resident Certificate issued by the Competent Authority.
 - v. Certificates from the District Industries Centre (DIC) and District Employment & Counselling Centre to the effect that no loan under self employment scheme has been taken by the appointee(s).

The appointment of above candidates, as Executive Officers in Urban Local Bodies, Jammu/Kashmir shall further be subject to the following conditions:-

- i. Each appointee shall give an undertaking to the effect that in case adverse report about his/her character and antecedents is received from the Inspector General of Police, (CID), J&K, to whom a reference shall be made by the Housing and Urban Development Department, he/she shall have no right to claim his/her appointment as Executive Officer in the Urban Local Bodies, and his/her

- appointment, as such, shall be deemed to have been cancelled ab-initio;
- ii. Verification/genuineness of the qualification, reserved category certificates and recognition of the Institutes from the concerned issuing authorities.

The salary of the appointee(s) shall not be drawn and disbursed to them unless the satisfactory reports in respect of (i) and (ii) above are received in their favour.

The appointment of the above candidates shall be governed by the Jammu & Kashmir Special Recruitment Rules as per SRO 202 of 2015 dated 30.06.2015.

The inter-se-seniority of the appointees shall be drawn in accordance with the merit secured by these candidates in the selection list prepared by the J&K Services Selection Board.

The appointment of the candidates shall be subject to outcome of the writ petition(s), if any, pending before any Competent Court of Law.
