It has been reliably learnt that Executive Officer, Municipal Committee, Chadoora (Budgam) namely Mushtaq Ahmad Wani s/o Abdul Samad Wani r/o Wathehed, Khansahib is highly corrupt. He is minting money in every matter through his below mentioned touts:-

1. Sahil Latief (Incharge Violation Section) r/o Munnipapy
2. Gulzar Ahmad Sheikh (Assistant Violation Section) r/o Khahipora Khansahib.
3. Nazir Ahmad Dar r/o BK Pora (posted at Municipal Office Chadoora).

It has also been learnt that the said officer firstly gives permission for illegal construction on monetary consideration through his above touts and later when the portion of the construction gets completed, he alongwith Tehsildar and SDM makes a surprise visits and stops the construction work and demands bribe from them to continue the illegal construction. It is also learnt that the said officer has received Rs.1300/- from every shopkeeper (around 1000 in number) of the Chadoora town for the purpose of registration with Municipality, however, neither the registration was done nor the payment was returned to them.

The input further reveals that the said officer is running a petrol pump near Bugroo Khansahib in the name of his nephew namely Mohd Younis Khanday r/o Watherhed Khansahib. It is also learnt that the officer has purchased land worth 02 crores at Nadrigund near PHQ Srinagar. The officer is posted as Incharge, Municipal Committee, Chadoora since March 2021 and has been given additional charge of Executive Officer, Municipal Committee, Kulgam by ULB department.

As desired, the input which depicts serious allegations against the above mentioned government officer/officials is shared for appropriate action.
