Subject: Re-Constitution of Committee of Officers.

**Government Order No. 141-JK (HUD) of 2022**  
**Dated 07.10.2022**

**Whereas**, vide Government order No 103-JK (HUD) of 2021 dated 07.07.2021, the following committee of Officers was constituted to conduct a detailed inquiry into the illegal appointments/regularizations made in Urban local bodies , Kashmir from the year 2001 till date:;

3. Mr Alyaz Ahmad Naisroo, JKAS, Secretary, LAWDA (now LCMA)

**Whereas**, the Committee during the course of verification, has observed that there are some other employees who have been appointed/ regularized illegally before the year 2001;

**Whereas**, the mandate of the Committee was to look into the illegal appointments/regularizations of all the employees engaged in the Urban local bodies , Kashmir, in violation of the J&K, Municipal Act, 2000/ rules;

**Whereas**, one of the committee member namely Mr Alyaz Ahmad Naisroo, Secretary, Lakes and Conservation Management Authority (erstwhile LAWDA), has been transferred and new officer posted in his place namely Mr Irfan Bhadur , JKAS by General Administration Department;

**Now, therefore**, it is ordered that the following Committee of Officers is hereby reconstituted to conduct a detailed enquiry into all the illegal appointments/regularizations made in the Urban Local Bodies Kashmir prior to 2001, without following due procedure of law:

1. Mrs. Mathora Masoom, JKAS ,Director Urban Local Bodies, Kashmir
2. Mr Showket Ahmad ,Mir, Special Secretary (Legal), Housing and Urban Development Department.
3. Mr Irfan Bhadur, JKAS, Secretary, Lakes Conservation and Management Authority, Srinagar

The Committee shall submit the report, within a period of 15 days.


