Post facto sanction is hereby accorded to the reimbursement of medical expenses amounting to Rs.8,39,770/- (Rupees Eight Lacs thirty nine thousand seven hundred and seventy only) in favour of Sh. Nissar Ahmad Rah, Head Assistant, Srinagar Municipal Corporation incurred on the treatment of his daughter namely Ms, Urooba in terms of rule 6 of the J&K Civil Services (Medical Attendance-cum-Allowance) Rules, 1990 and also grant of advance drawal of 75% of the estimated cost of treatment i.e. Rs. 12,45,00 (Rupees twelve lacs and forty five thousand only) in terms of Rule 6(4) of the J&K Civil Services (Medical Attendance-cum-Allowance) Rules, 1990 duly authenticated from the hospital where from treatment is to be taken. However the advance drawal shall be made in the form of demand draft directly to the concerned hospital. This sanction shall be subject to the fulfillment of following conditions:

1. The terms and conditions as laid down in J&K Medical Attendance Rules of 1990 shall be strictly adhered to.
2. The treatment shall be admissible under rules and reimbursement shall be restricted to the admissible items/procedures for the period of hospitalization and cost thereof shall be restricted to the extent of rates as applicable to such items/procedures at AIIMS, New Delhi.
3. The payment shall be released after fulfillment of codal formalities.
4. The Red Account/Adjustment Bill shall be furnished to the Accountant General J&K Srinagar in respect of advance within stipulated time.
5. Essentially certificate on Form-2 issued by the hospital authorities is obtained and kept on record.

6. Dependency of the patient on the Official is established under rules before reimbursement of the claim.


