Sanction is hereby accorded to the release of **Rs.8.30 crore (Rupees Eight Crore & Thirty lakh only)** as Central Assistance under A&OE component for Preparation of City Water Balance Plan (CWBP) under AMRUT 2.0 during the year 2021-22.

The Director Finance H&UDD shall draw the funds in advance from treasury through WDC bill and credit the same in the official Bank A/c of **Single Nodal Agency of AMRUT bearing official bank A/c No. 0404040500008677 maintained with J&K Bank Old Secretariat, Srinagar having IFSC Code: JAKAORTOSGR with title of Account: AMRUT Director Urban Local Bodies, Kashmir.**

However, the release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the funds shall be utilized for the purpose these have been released as per the approved activity-wise action plan as detailed hereunder:-

- (ii) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (iii) the amount of advance is out of the ULBs share of A&OE funds allocated for the Mission period and will be adjusted in their share at the time of release of further installments;

- (iv) the funds shall be utilized for the purpose of A&OE component of **AMRUT 2.0** for which it has been sanctioned/released and no diversion of Central Grants for purpose of other than the A&OE component of AMRUT 2.0 is allowed and shall entail levy of penal interest on the amount and any other action by the Apex Committee and may include adverse effect on release of further Grants.
- (v) the funds shall be utilized for execution of the scheme strictly as per originally approved components and according to GOI's prescribed guidelines which have been technically sanctioned and administratively approved by the Competent Authority;
- (vi) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (vii) the funds so released shall not be available for any re-appropriation/diversion;
- (viii) the expenditure shall commensurate with the physical progress achieved;
- (ix) all video graphic/photographic evidence of works both shall be maintained.
- (x) the physical and financial progress report alongwith Utilization Certificate of the funds released shall be furnished as early as possible and definitely well before 31.3.2022 to GOI, with a copy to Finance Department.
