Sanction is hereby accorded to the release of **Rs.9376.25 lacs (Rupees Ninety three Crore Seventy Six lacs and Twenty Five thousand only)** out of the released amount by MoH&UA of Rs. Rs.95.64 Crore, in favour of Mission Director AMRUT 2.0 as balance 3<sup>rd</sup> instalment of Central Assistance against SAAP-I,II & III under AMRUT during 2021-22 for implementation of various projects as per the activity-wise description given hereunder:-

With this release the total Central share released to MD AMRUT aggregates to the tune of Rs. 475.8625 crore for JKUT from inception of the scheme.

The Director Finance, H&UDD shall draw the funds in advance from the Treasury through WDC Bill and credit the same in the official Bank A/c of Single Nodal Agency of AMRUT bearing Account No. 0404040500008677 **maintained at J&K Bank Old Secretariat Srinagar being operated by Director urban Local Bodies, Kashmir having IFSC code: JAKAORTOSGR.**

However, the release & subsequent utilization of funds is subject to the following conditions that:-

The release & subsequent utilization of funds is subject to the following conditions that:-

- i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- ii) the funds shall be utilized for execution of the scheme strictly as per originally approved components and according to GOI's prescribed guidelines which have been technically sanctioned and administratively approved by the Competent Authority;
- iii) execution of projects shall be carried out strictly **as per approved** SAAP allocation and allotted cost whichever is less and as per approved DPR by the State Level High Power Committee (SLHPSC)
- iv) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- v) the funds so released shall not be available for any re-appropriation/diversion;
- vi) the expenditure shall commensurate with the physical progress achieved;

- vii) all video graphic/photographic evidence of works both shall be maintained.
- viii) Saving if any on the project under AMRUT against which eligible CA is calculated/released shall be remitted by the Mission Director to the consolidated fund of India through the Adm. Deptt.
- ix) The Mission Director/Implementing Agencies shall comply with the observations with the IRMA and shall furnish the compliance report issued by IRMA through Adm. Deptt.
- x) The Mission Director/ Implementing Agencies/SNA shall deposit all interest (except already adjusted interest) earned on the CA till date with the Ministry through the Adm. Deptt.
- xi) the physical and financial progress report alongwith Utilization Certificate of the funds released shall be furnished as early as possible and definitely well before 31.3.2022 to GOI, with a copy to Finance Department.
- The expenditure on this account shall be debited to the following budget classification:-


