The terms of reference of the Fact Finding Committee shall be as under:-

(i) To look into the initial appointment/promotions of Mr. Firdous Ahmad Qazi, presently Executive Engineer, Jammu Municipal Corporation (previously borne on the establishment of Directorate of Urban Local Bodies, Jammu) and

(ii) To verify whether his appointment is in consonance with the prescribed Rules.

Further, erstwhile fact finding committee, constituted vide G.O. No. 75-JK(HUD) of 2022 dated 25.05.2022, shall handover all documents related to the case, in the instant matter to the newly constituted committee.

The committee shall submit the report within 15 days from the date of issuance of this order.
