In terms of the Jammu and Kashmir Civil Services (Leave Travel Concession) Rules, 2019, sanction is hereby accorded to the grant of Leave Travel Concession (block 2020-2023) in favour of Sh. Raj Gopal Sharma, Assistant Executive Engineer, Sewerage & Drainage Division (West) Jammu, UEED (J&K), with effect from 20.12.2023 to visit Chennai with his son, subject to the following conditions:-

- i. *The claim is covered under J&K Civil Services (LTC) Rules, 2019.*
- ii. *The officer or his dependents have not availed such concession earlier during the LTC block 2020-23.*
- iii. *The leave applied by the officer is sanctioned by the Competent Authority.*
- iv. *The dependency of the family members on the officer is established under rules.*
- v. *Entry to this effect is recorded in the service book of the officer.*
- vi. *Journey to visit Chennai is performed by the shortest route.*
- vii. *The entitlement is regulated by the concerned Drawing & Disbursing Officer under rules.*
- viii. *The other conditions for grant of this concession shall be same as laid down in the Jammu and Kashmir Civil Services (Leave Travel Concession) Rules, 2019.*


