- 2. The funds shall be utilized strictly in accordance with the project Guidelines and for the purpose for which it have been sanctioned/released and strictly in terms of the condition stipulated in the above referred sanction letter/release order of Ministry of Jal Shakti,Gol and Finance Department.
- 3. E-tender shall be invited, wherever applicable.
- 4. All relevant provisions of the approved scheme, GFR 2017 and economic instructions issued by the UT/Central Govt. shall be complied with;
- 5. The funds so released shall not be available for any re- appropriation/ diversion.
- All necessary instructions relating to implementation of Single Nodal Agency System issued by Department of Expenditure vide OM No. I(13)PFMS/ FCD/2020 dated 23rd March, 2021 and further instructions issued till date shall be complied with regard to monitoring and utilization of funds;
- 7. There should not be any overlapping of activities under the project with the activities of any other ongoing schemes under CSS/CS/UT Govt. scheme;
- 8. The fixed assets created out of this grant shall not be disposed of without prior concurrence/approval of the competent authority;
- 9. The expenditure shall commensurate with the physical progress achieved;

- 10. The released funds are placed at the disposal of the executing department for utilization as per the actual work done claim after due physical verification;
- 11. The physical and financial progress report along with the Utilization Certificate of the funds released shall be furnished as early as possible and definitely well before 31.03.2025 to Gol, with a copy to Finance Department.
- 12. The funds shall be utilized for implementation of schemes strictly as per originally approved components/according to Government of India prescribed guidelines and prior approval of the Competent Authority.
- 13. The SNA shall send report about the scheme in terms of Physical and Financial Progress made during the current year upto date cumulative expenditure and physical achievements.
- 14. The SNA shall release funds to the Child Agencies after obtaining prior approval of the competent authority along with drawing limit through PFMS.
- 15. The SNA and the Implementing Agency shall mandatorily use the EAT module of PFMS or integrate their systems with the PFMS to ensure that information on PFMS is updated at least once every day.
- 16. In order to strengthen the monitoring mechanism and ensure transparency in project. implementation, Third Party Inspection (TPI) system shall be put in place. Their reports are to be examined on a continuous basis and action as appropriate to ensure progress of works in consultation with Gol/Adm Department. Further release of funds shall be subject to satisfactory progress being ensured.
- 17. Video graphic/photographic evidence of the works (at different stages of construction i.e. pre, post and during) shall be maintained and preserved. The photographs with geo-coordinates shall be uploaded through Proof Application on BEAMS;
