21 days from the date of issuance of the list. The objections must be filed /forwarded through concerned Chief Town Planner, Town Planning Organization, Jammu/Kashmir so as to reach the Administrative Department within a stipulated time. Further, no objections in this regard shall be entertained after expiry of the stipulated time period.
