- 3. That the AAA shall not be treated as an authorization to spend money which is not provided for in the budget and completion of these schemes shall be ensured during stipulated periods to avoid any cost revision/escalation.
- 4. Definite timelines be set for completion of the project and project completed without any cost or time overrun.
- 5. The department shall ensure that all codal formalities including provisions of GFR and Works Manual are strictly adhered to during execution of the project.
- 6. The department shall ensure availability of funds out of approved/ earmarked resources.
- 7. The funds so released shall be utilized by the concerned authority only for the purpose specified after observing all prerequisite formalities/ procedures as per GFR and shall not be available for further re appropriation/ diversion at any level and for any reason whatsoever. 8. The execution of works shall be taken up strictly for the approved activities only within the approved cost and no extra liability shall be created to ensure cost optimization & financial discipline.
- 9. The department shall obtain NOCs from the concerned departments/ agencies, as applicable.
- 10. The conditions laid in DPRs be strictly followed.
- 11. The physical/financial progress shall be monitored by the department on regular basis.
- 12. That the actual construction shall be taken up only after accord of technical sanction by the competent authority.
- 13. That the Electrical/ Mechanical Components are authenticated and technically vetted by the competent authorities of relevant field.
- 14. That in no case the execution shall exceed the approved cost at any stage without approval of the competent authority.

- 15. That the NOC from concerned PCB/I&FC/Forest Department is sought before the commencement of work.
- 16. That the structural design of each work is got authenticated by Competent Authority.
- 17. That the project and its allied accessories like land etc are encumbrance free.
- 18. That proper codal procedure mandatory as per standing Government rules/ regulations/manuals is followed for finalization of award of contract to ensure transparency and economy.
- 19. That e-tendering mode is followed for fixation of award of contract for execution of the project and working DPR is followed in the formation of BOQ for e-tendering purpose of the project.
- 20. That proper rate analysis and market survey has been conducted in light of standing rules and procedures in case of all the items proposed to be executed on ground, prior to issuance of formal NIT for the project, in order to ensure rationality of rates.
- 21. That there will be no such condition kept in bidding documents which shall restrict the competition.
- 22. Administrative approval shall be subject to release of funds from the competent authority.
- 23. The physical/financial achievements shall be submitted to the Administrative Department well before the set timeline.
- 24. It must be ensured that there shall be no multi-source of funding or overlapping of scheme under different programmes.
- 25. That the execution of the project is strictly adhered to the approved parameters of both technical sanction and administrative approval.
- 26. That the facility shall yield Halal Certified product.

The accord of administrative approval shall not however, be treated as an authority to:

- a. Spend money not provided for; in the budget;
- b. Create new posts of any provided for in the Administrative Approval.
