Sanction is accorded to the release of Rs **25.00 lacs (Rupees Twenty Five lacs only)** in favour of Managing Director J&K Housing Board Jammu under the scheme of "Construction of Community/Town Halls" of Housing Sector - Capex Budget 2015-16 to be utilized on Construction of Community/Town Hall at Sangri Baramulla at an estimated cost of Rs. 160.00 lacs during the year 2015-16.

The Director, Finance H&UDD shall draw the funds in advance from Treasury through WDC Bill and place the same at the disposal of MD J&K Housing Board Jammu.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the scheme only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the funds shall not be utilized on clearance of any past liability, repair renovation & Maintenance work
- (iv) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (v) the funds so released shall not be available for any re- appropriation /diversion;
- (vi) the expenditure shall commensurate with the physical progress achieved and all video graphic/photographic evidence of works both shall be maintained.
- (vii) the UCs for the released amount shall be submitted well in time ;

the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;


