- Subject:- Release of funds under the scheme Emergency Public Demand of Urban Development Sector - Annual Plan 2014-15.

Dated 27 -03-2015

Sanction is accorded to the release of funds to the tune of Rs.10.00 lacs (Rupees Ten lacs) only in favour of Commissioner, Municipal Corporation, Srinagar under the scheme "**Emergent Public Demands**" of Urban Development Sector of Annual Plan 2014-15 to be utilized for the Construction of Cement Concrete Drain including manholes at Usman Abad Bemina Srinagar.

The Director, Finance H&UDD shall draw the funds in advance from Treasury through WDC Bill and place the same at the disposal of concerned Corporation in the shape of Hundie.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the funds shall not be utilized for the schemes/works which have not been approved by the Administrative Department.
- (iv) the funds shall not be utilized on clearance of any past liability, repair renovation & Maintenance work
- (v) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (vi) the funds so released shall not be available for any re-appropriation/diversion;
- (vii) the expenditure shall commensurate with the physical progress achieved;
- (viii) all video graphic/photographic evidence of works both shall be maintained.
- (ix) the physical and financial progress report shall be furnished to the Administrative Department well in time;

- (x) the implementing agency shall follow up the procedural mechanism of CAS – MIS System;
- (xi) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.
