**Government Order No: - 105 -HUD of 2016**  
**Dated 22-03-2016**

In continuation to Govt. Order No. 05-HUD of 2015 dated 06.01.2016, sanction is accorded to the further release of **Rs. 375.00 lacs (Rupees Three Hundred Seventy Five lacs) only) in favour of Mission Director AMRUT under Capex Budget 2015016** of Urban Development Sector, to be utilized as State Share for AMRUT for the year 2015-16, thereby aggregating total releases under the scheme to the tune of **Rs. 13.75 Crore during 2015-016**.

The Director Finance, H&UDD shall draw the funds in advance from Treasury through WDC Bill and credit the same in the official Bank of Mission Director AMRUT bearing A/c No. 0110040500000061 for further releases to the implementing agencies.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the agency shall transfer the funds to the implementing agencies as per the financial pattern in the guidelines of GOI for the programme under AMRUT and for the specific purpose for which it has been released;
- (ii) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (iii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority & as per the guidelines of the scheme.
- (iv) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (v) the funds so released shall not be available for any re-appropriation/diversion;
- (vi) the expenditure shall commensurate with the physical progress achieved;



- (vii) the Director Finance of the Department shall vouchsafe the utilization of funds as per codal procedure/guidelines.
- (viii) the Utilization certificate for the released amount shall be submitted to the Department within the stipulated time;
- (ix) all video graphic/photographic evidence of works both shall be maintained.
- (x) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- (xi) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.


