Sanction is accorded to the release of funds to the tune of Rs.114.00 lacs (Rupees One Hundred Fourteen lacs only) with the break-up of Rs. 84.39 lacs and Rs. 29.61 lacs each in favour of Director Urban Local Bodies Jammu and Director Urban Local Bodies Kashmir under the scheme "IDMT" of Urban Development sector of Annual Plan 2014-15 **to be utilized on account of workdone claims of the works to the extent of amount shown against each in the Annexure-A to this Govt. Order.**

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the funds shall be utilized on the ongoing schemes/works only and no funds shall be utilized for the schemes/works which have not been approved by the Administrative Department.**
- (iv) the funds shall not be utilized on repair renovation & Maintenance work
- (v) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (vi) the funds so released shall not be available for any re-appropriation/diversion;
- (vii) the expenditure shall commensurate with the physical progress achieved;
- (viii) all video graphic/photographic evidence of works both shall be maintained.
- (ix) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;

- (x) the implementing agency shall follow up the procedural mech. Of CAS – MIS System;
- (xi) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.
