Sanction is accorded to the release of funds amounting to Rs. 50.00 lacs (**Rupees Fifty lacs only**) in favour of Chief Engineer, PHE Jammu under Urban Development sector of Annual Plan 2014-15 to be utilized on shifting of utilities for laying of Sewer Lines by NBCC in old Jammu city under UIDSSMT.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the schemes only which have been **Technically sanctioned and Administratively approved by the Competent Authority**;
- (iii) the funds shall be utilized on the ongoing schemes/works only.
- (iv) the funds shall not be utilized on clearance of any past liability, repair renovation & Maintenance work;
- (v) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (vi) the funds so released shall not be available for any re-appropriation/diversion;
- (vii) the expenditure shall commensurate with the physical progress achieved;
- (viii) that all video graphic/photographic evidence of works both shall be maintained;
- (ix) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- (x) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.
