In continuation to Govt. Order No. 64-HUD of 2018 dated 23.02.2018, sanction is here by accorded to the release of **Rs. 10.00 Crore (Rupees Ten Crore)** only in favour of **Vice Chairman, J&K Lakes and waterways Development Authority (LAWDA)** under Dal Development Sector of State Capex Budget 2017-18 to be utilized for implementation of the Revised Action Plan/works programme approved during current financial year as detailed in **Annexure-"A"** to this Govt. Order, thereby, aggregating total releases to the extent of Rs. 50.00 Crore only under Dal Development Sector during current financial year.

The Director Finance, H&UDD shall draw the funds in advance from treasury through WDC Bills and place the same at the disposal of Vice Chairman, J&K Lakes and waterways Development Authority (LAWDA).

The release & subsequent utilization of funds is subject to the following conditions that:

- i. the funds shall be placed at the disposal of subordinate executive agencies within seven days from the issuance of the order and copy endorsed to the Administrative Department;
- ii. the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities, expenditure be restricted only within approved allocation and no liability be created on this account;
- iii. the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- iv. the funds shall not be utilized on clearance of any past liability, repair and maintenance work;
- v. the funds shall be utilized on the ongoing schemes/works only and no new scheme shall be taken up without the approval of the competent authority;
- vi. the implementing agency shall ensure that there is no overlapping of funds for the works being executed form any other source such as SDRF/State Plan/District Plan/CSS/BADP/Flagship programme or any other source;

- vii. the funds so released shall not be available for any re-appropriation/diversion;
- viii. the expenditure shall commensurate with the physical progress achieved;
- ix. the UCs for the released amount shall be submitted to the department for release of further funds;
- x. the implementing agency shall vouchsafe the utilization of funds as per codal procedure/guidelines;
- xi. all the UCs/Red accounts of advance draws shall be rendered to the concerned quarters;
- xii. the physical and financial progress report shall be furnished to the Admin. Deptt. well in time, i.e. 5th of succeeding months;
- xiii. that all video graphic/photographic evidence of works both pre-execution and post execution shall be maintained
