Subject:-Release of funds under Housing Sector scheme for the year 2014-15.

Reference: - Planning & Dev. Department's authorization conveyed vide G.O.
No: - 45-PD of 2015, dated:-13.03.2015.

Sanction is hereby accorded to release of funds amounting to Rs.450.00 lacs (Rupees Four Crores and Fifty lacs) only along with advance drawl as Additionalities in favour of Managing Director J&K Housing Board under the scheme up gradation of civic amenities in Housing Colonies and Construction of Community Halls under Housing Sector - (Capital Components) during current financial year 2014-15.

The Director Finance H&UDD shall draw the funds in advance through WDC bill from the Treasury and place the same at the disposal of Managing Director J&K Housing Board.

However, the release of funds is subject to the completion of the following condition:-

- i. The release of funds does not confer the sanction to incur the expenditure and shall be booked only after observing all codal formalities;
- ii. The funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the competent Authority;
- iii. The executing agency shall ensure that there is no overlapping of funds for the works being executed;
- iv. The executing agency shall furnish physical/financial progress report to this department by or before 5th of every month;
- v. The funds so released shall not be available for any re-appropriation/diversion;
- vi. The utilization certificate for the released amount shall be submitted for release of 2nd installment;
- vii. The Director Finance of the department shall vouchsafe the utilization of funds as per codal procedure/ guidelines;
- viii. All the UC's/Red Accounts of previous advance drawls have been rendered to the concerned quarters;
- ix. The Red Accounts is expedited to the Audit Office without any delay;

The expenditure on this account shall be debited as per following classification for proper accounting:-

- Demand No: 19
- Major Head: 4216-Capital outlay on Housing.
- Sub-major Head: 01 Residential Buildings.
- Minor Head: 700-Other Housings.
- Group Head: 011-State Plan SPA.
- Sub-Head: 0893 Other Housing Schemes.
