In continuation to Govt. Order No. 51-HUD of 2015 dated 19.2.2015, sanction is accorded to the release of funds to the tune of Rs. **318.75 lacs (Rupees Three Hundred Eighteen lacs and Seventy Five thousand) only** in favour of **Commissioner Municipal Corporation Jammu** under different schemes of Urban Development Sector to the extent of amount shown against each to be utilized on approved ongoing schemes/works only during year 2014-15:-

The Director Finance H&UDD shall draw the funds in advance from Treasury through WDC Bill and place the same at the disposal of concerned Corporations in the shape of Hundi.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the funds released under Street Lights shall be utilized for the purchase of LED lights from Original Equipment Manufacturer ( OEM) on competitive rates and outsource the restoration job on competitive bidding after clearly marking the defunct lights;
- (iv) the warranty clause of 24 months from, the date of installation shall be incorporated in the allotment of the contract.
- (v) the funds released under CCDP over and above the current approved allocation shall not be utilized without the approval of Administrative Department.

- (vi) the funds shall be utilized on the ongoing schemes/works only and no new scheme shall be taken up without the approval of the competent authority;
- (vii) the funds shall not be utilized on clearance of any past liability, repair renovation & Maintenance work
- (viii) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (ix) the funds so released shall not be available for any re-appropriation/diversion;
- (x) the expenditure shall commensurate with the physical progress achieved;
- (xi) all video graphic/photographic evidence of works both shall be maintained.
- (xii) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time
- (xiii) the implementing agency shall follow up the procedural mech. Of CAS – MIS System.
