The Director Finance H&UDD shall draw the funds in advance through WDC Bill and credit the same in the office account of J&K SUDA bearing No. 5976 maintained at J&K Bank Moving Branch Civil Secretariat, Jammu/Srinagar.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the funds shall be utilized on the ongoing schemes/works only and no funds shall be utilized for the schemes/works which have not been approved by the Administrative Department.
- (iv) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (v) the funds so released shall not be available for any re-appropriation/diversion;
- (vi) the expenditure shall commensurate with the physical progress achieved;
