The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- the funds released under Street Lights shall be utilized for the purchase of LED lights from Original Equipment Manufacturer (OEM) on competitive rates and outsource the restoration job on competitive bidding after clearly marking the defunct lights;
- (iv) the warranty clause of 24 months from, the date of installation shall be incorporated in the allotment of the contract.
- (v) the funds released under CCDP over and above the current approved allocation shall not be utilized without the approval of Administrative Department.
- (vi) the funs shall be utilized on the ongoing schemes/works only and no new scheme shall be taken up without the approval of the competent authority;

- (vii) the funds shall not be utilized on clearance of any past liability, repair renovation & Maintenance work
- (viii) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (ix) the funds so released shall not be available for any reappropriation/diversion;
- (x) the expenditure shall commensurate with the physical progress achieved;
- (xi) all video graphic/photographic evidence of works both shall be maintained.
- (xii) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time
- (xiii) the implementing agency shall follow up the procedural mech. Of CAS MIS System.
