In continuation to Govt Order 86 – HUD of 2018 dated 20.03.2018, sanction is hereby accorded to the release of funds to the tune of **Rs. 25.00 Lakh (Rupees Twenty Five Lakh)** only in favour of **Managing Director, J&K Housing Board** under State Capex Budget 2017-18 of Urban Development Sector to be utilized for execution of emergent nature of work viz; "Road from Naj Bridge to Naj Playground Billawar" during current financial year 2017-18, thereby aggregating total releases to the extent of Rs. 50 Lakh only under the scheme/work during Current financial Year 2017-18.

The Director Finance, H&UDD shall draw the funds in advance from treasury through WDC Bills and place the same at the disposal of Managing Director, J&K Housing Board immediately.

The release & subsequent utilization of funds is subject to the following conditions that: -

- (x) the funds shall be placed at the disposal of subordinate executive agencies within seven days from the issuance of the order and copy endorsed to the Administrative Department;
- (xi) the implementing agency shall ensure that there is no overlapping of funds, for the works being executed from any other source such as SDRF/State Plan/District Plan/CSS/BADP or any other source;
- (xii) the funds so released shall be utilized for proper purpose and not to be benefited to any individual;
- (xiii) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (xiv) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (xv) the funds so released shall not be available for any re-appropriation/diversion;
- (xvi) the next instalment of funds shall be released after furnishing the Utilization Certificate of the previous funds and shall ensure that the Utilization Certificate of the amount is rendered to the concerned quarter within the stipulated time;
- (xvii) the expenditure shall commensurate with the physical progress achieved;
- (xviii) that all video graphic/photographic evidence of works both pre-execution and post execution shall be maintained;
