Sanction is accorded to the release of funds to the tune of Rs. **100.00 lacs (Rupees One Hundred lacs)only in favour of Commissioner Municipal Corporation Srinagar** under the scheme "EPD" of Urban Development Sector under Annual; Plan 2014 -15 to be utilized on approved schemes/works only during year 2014-15 :-

The Director Finance H&UDD shall draw the funds in advance from Treasury through WDC Bill and place the same at the disposal of concerned Corporations in the shape of Hundi.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the funds shall be utilized on the ongoing schemes/works only and no new scheme shall be taken up without the approval of the competent authority;
- (iv) the funds shall not be utilized on clearance of any past liability, repair renovation & Maintenance work
- (v) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (vi) the funds so released shall not be available for any re-appropriation/diversion;
- (vii) the expenditure shall commensurate with the physical progress achieved;
- (viii) all video graphic/photographic evidence of works both shall be maintained.
- (ix) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time
- (x) the implementing agency shall follow up the procedural mech. Of CAS - MIS System.
