Sanction is hereby accorded to the release of funds to the tune of *Rs. 159.67 Lacs (Rupees One Hundred Fifty Nine Lacs and Sixty Seven Thousand) only in favour of Superintending Engineer Drainage Circle SMC, Srinagar* under Urban Development sector – Capex Budget 2015-16 for its further placement at the disposal of concerned Executive Engineer Sewerage & Drainage (SMC), to be utilized for ongoing approved schemes/works for settlement of work done claims as per the work wise breakup given in Annexure "A" to this Govt. order: -

The release & subsequent utilization of funds is subject to the following conditions that:-

- i. *The implementing shall ensure that there is no overlapping of funds, for the works being executed from any other sources such as SDRF, District Plan, CSS, BADP, PM's Package, CDF, MPLADS. Etc.*
- ii. the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- iii. the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- iv. the funds so released shall not be available for any re-appropriation/diversion;
- v. the expenditure shall commensurate with the physical progress achieved and all video graphic/photographic evidence of works both shall be maintained.
- vi. the Utilization Certificates for the released amount shall be submitted well in time;
- vii. the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- viii. no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.


