Sanction is hereby accorded to: -

- (i) Meeting balance unit cost for PCC /Masonry and Fiber Reinforced Plastic structure for construction of IHHTs from State Capex Budget to the tune of Rs. 13490/- and Rs.12540/- respectively including Rs.445/- as 10% Matching State Share against the admissible central assistance of Rs. 4000/-.
- (ii) Meeting balance unit cost for construction of CTs/PTs comprising of five seats, two bathrooms, caretaker room and two Urinals from State Capex Budget @ Rs. 11.38 lacs for Kashmir Region/Hilly Region of Jammu & @ Rs. 8.28 lacs for plain areas of Jammu region inclusive of Rs.24,622/- as 10% matching State Share.
- (iii) Inviting tenders for Solid Waste Management Projects under PPP mode and in case of poor response particularly for clusters with low waste generation, deficit to be met out of State Capex Budget.


