Sanction is accorded to the release of **Rs.300.00 lacs (Rupees Three Hundred lacs only)** in favour of Director, Urban Local Bodies, Jammu as an additionality under Drainage sector, out of the overall saving of the Annual Plan 2014-15 of H&UDD for its further placement at the disposal of Executive Engineer Town Drainage Division Jammu **to be utilized on approved ongoing schemes/works only during 2014-15, as detailed in Annexure-A to this Govt. Order.**

The release & subsequent utilization of funds is subject to the following conditions that

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the funds shall be utilized on the ongoing schemes/works only;
- (iv) the funds shall not be utilized on clearance of any past liability, repair renovation & Maintenance work;
- (v) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (vi) the funds so released shall not be available for any re-appropriation/diversion;
- (vii) the expenditure shall commensurate with the physical progress achieved;
- (viii) all video graphic/photographic evidence of works both shall be maintained;
- (ix) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;

- (x) the implementing agency shall follow up the procedural mechanism of Web CAS –MIS System.
- (xi) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.




