Consequent upon the concurrence of the Finance Department as quoted above for advance drawal of Capex Budget 2016-17 under Urban Development Sector parked in the "**Account Head 8443 – Civil Deposit**", sanction is hereby accorded to the release of **Rs. 275.00 Lacs (Rupees Two Hundred Seventy Five Lacs)** only in favour of Commissioner SMC/JMC of Capex Budget 2016-17 under Urban Development Sector to be utilized for implementation of District Board Decision of Srinagar and Jammu for clearance of workdone liabilities and completion of ongoing schemes/works in consultation with Hon'ble MLAs under the scheme Capital City Development Programme (CCDP) as per following breakup:

The 2<sup>nd</sup> instalment of equal amount shall be drawn in advance after full utilization of 1<sup>st</sup> instalment for which order shall be issued separately.

The Director, Finance H&UDD shall draw the funds in advance from Treasury through WDC Bill and place the same at the disposal of Commissioner, SMC and Commissioner, JMC.

The release & subsequent utilization of funds is subject to the following conditions that: -

- i. the funds shall be placed at the disposal of subordinate executive agencies within seven days from the issuance of the order and copy endorsed to the Administrative Department;
- ii. the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- iii. the execution of the works be taken up after seeking formal approval of the works so identified/prioritized from the Administrative Department;
- iv. the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;

P.T.O

- v. the implementing agency shall ensure that there is no overlapping of funds for the works being executed from any other source such as

SDRF/State Plan/District Plan/CSS/BADP/Flagship programme or any other source;

- vi. the funds so released shall not be available for any re-appropriation/diversion;
- vii. the expenditure shall commensurate with the physical progress achieved.
- viii. the UCs for the released amount shall be submitted to the department for release of further funds;
- ix. the implementing agency shall vouchsafe the utilization of funds as per codal procedure/guidelines;
- x. all the UCs/Red accounts of advance draws shall be rendered to the concerned quarters;
- xi. the physical and financial progress report shall be furnished to the Admin. Deptt. well in time;
- xii. that all video graphic/photographic evidence of works both pre-execution and post execution shall be maintained;
