The drawing & Disbursing Officer is required to observe the following instructions strictly;

- The expenditure shall be made strictly in accordance to the classification under which funds have been authorized. No omissions/Commissions or diversion shall be made under any pretext unless specifically and separately authorized.
- There should be uniform expenditure under each object head to avoid rush of expenditure during the last quarter of the financial year.
- 3. The controlling officers shall be duty bound to ensure submission of revenue and expenditure statements to this Department on monthly basis.
- 4. The controlling Officers/DDOs shall conduct periodic reconciliation of remittances and drawal with the Treasury and the office of the Accountant General (A&E) J&K to ensure correct reflection of income and expenditure in the Finance and other Accounts.
- The Utilization certificate//Red Accounts of previous drawal have been rendered to the concerned quarter without any delay.
- The controlling Officer ensure that the released funds does not confer the sanction for incur
 the expenditure which shall be booked after observing all codal formalities.
