The Director, Finance H&UDD shall draw the funds in advance from Treasury through WDC Bill and place the same at the disposal of Chief Executive Officer, Katra Development Authority (KDA) through RTGS .

The release & subsequent utilization of funds by the CEO, Katra shall be subject to the following conditions that: -

- i. the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- ii. the funds so released shall not be available for any re-appropriation/diversion;
- iii. the UCs for the released amount shall be submitted to the department for securing accounts;
- iv. the implementing agency shall vouchsafe the utilization of funds as per codal procedure/guidelines;
- v. all the UCs/Red accounts of advance drawls shall be rendered to the Accountant General Office;
- vi. the physical and financial progress report shall be furnished to the Admin. Deptt. well in time;
