- vi. the funs shall be utilized on the ongoing schemes/works only and no new scheme shall be taken up without the approval of the competent authority;
- vii. the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- viii. the funds so released shall not be available for any reappropriation/diversion;
- ix. the expenditure shall commensurate with the physical progress achieved;
- x. all video graphic/photographic evidence of works both shall be maintained;

- xi. the physical and financial progress report shall be furnished to the Admin. Some Deptt. well in time;
- xii. no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.
