- iii. The funds shall be utilized on the ongoing schemes/works only and no new scheme shall be taken up without the approval of the competent authority;
- iv. The implementing agency shall ensure that there is no overlapping of funds for the works being executed from any other source such as SDRF/State Plan/District Plan/CSS/Flagship programme or any other source;



- v. The funds so released shall not be available for any re-appropriation/diversion;
- vi. The expenditure shall commensurate with the physical progress achieved;
- vii. All video graphic/photographic evidence of works both shall be maintained;
- viii. The physical and financial progress report shall be furnished to the Admin. Deptt. well in time;
- ix. No expenditure shall be incurred against revised cost which has not been approved by the competent authority;
