Subject: -Release of funds as grant-in aid (Central Share) of 2013-14 under Central Sponsored Scheme (SJSRY) for clearance of liability under STEP-UP 2012-13 in favour of District Urban Development Agencies.

Reference:-Ministry of Housing & Urban Poverty Alleviation Government of India letter No:-G-24011/ 06/ 2013-UPA/ FTS: 8279, dated:-14.06.2013, sanction letter No;-F-No.G-24011/ 6/ 2013-UPA, dated:-8 and 14th August 2013 and subsequent receipt of Rs.453.75 lacs in the official bank account of SUDA through DBT.

Sanction is hereby accorded to the release of funds amounting to Rs.49.49 lacs (Rupees Forty Nine Lacs and Forty Nine Thousand only) out of funds received from Ministry of Housing & Urban Poverty Alleviation GoI as Grant-in-Aid (Central Share) during the year 2013-14 and placement of the same at the disposal of Chief Executive Officer UDAK for clearance of liabilities on account of STEP-UP- SJSRY scheme of the year 2012-13 as per following details:-

However, the accord of sanction of funds is subject to the following conditions:-

- i. The payment to the institutions shall be made only in respect of the candidates who have attended the course with 80% attendance and who have been declared passed as per guidelines of SJSRY/NULM.
- ii. The payment shall be made to the institutions that are registered/recognized with Board of Technical Education/Skill Development Corporation/DOECC /VTP or any other government/Semi government institutions as per guidelines of G.O.India.
- iii. The institute shall provide certificates which are recognized by the Government of India/State Government.
- iv. The payment of liability shall be done strictly as per the proportion of availability of funds and liability of institutes.

- v. The release of funds does not confer the sanction to incur the expenditure and shall be booked only after observing all codal formalities.
 - vi. The funds shall be utilized on those components of the schemes only for which these have been released and no appropriation/diversion shall be made towards any other component of the SJSRY scheme.
 - vii. The saving if any shall not be re-appropriated towards any other component without the approval of the competent authority,
 - viii. The implementing agency shall ensure that there is no overlapping of funds for the works/schemes being executing;
 - ix. The expenditure shall commensurate with the physical progress achieved;
 - x. The CEO/PO shall ensure that the payment to institutes on account material made only against the material consumed by the trainees during the training course and no payment is made on account of administrative /miscellaneous charges.
 - xi. The DUDA's shall furnish physical/financial progress report to this department on monthly basis as per the payments made to institutions/training providers.
 - xii. The utilization certificate of the funds released shall be furnished to this department expeditiously within 10 days.
 - xiii. The interest money (if any) accrued on these funds during the parking in the Bank Account shall not be utilized without the approval of Administrative Department.
- Any deviation in non fulfilment of aforementioned conditions shall be treated as misappropriation of funds.**


