Sanction is hereby accorded to the release of funds amounting to **Rs.146.40 Lakhs (Rupees One Crore forty six lakhs and forty thousand only)** during the current financial year i.e 2018-19 under Grant-In-Aid in favour of SUDA for further release in favour of JUDA, UDAK and DUDAs raising the total allocation to **Rs.314.40 lakhs (Rupees Three Crore and Fourteen Lakhs and Forty Thousand only)** for meeting the expenses under revenue account.

The Director Finance Housing & Urban Development Department shall draw the amount in advance from the concerned treasury through WDC bill and same shall be transferred to the official account of the SUDA.

The drawing & Disbursing Officer is required to observe the following instructions strictly;

1. The expenditure shall be made strictly in accordance to the classification under which funds have been authorized. No omissions/Commissions or diversion shall be made under any pretext unless specifically and separately authorized.
2. There should be uniform expenditure under each object head to avoid rush of expenditure during the last quarter of the financial year.
3. The controlling officers shall be duty bound to ensure submission of revenue and expenditure statements to this Department on monthly basis.
4. The controlling Officers/DDOs shall conduct periodic reconciliation of remittances and drawal with the Treasury and the office of the Accountant General (A&E) J&K to ensure correct reflection of income and expenditure in the Finance and other Accounts.
5. The Utilization certificate//Red Accounts of previous drawal have been rendered to the concerned quarter without any delay.
6. The controlling Officer ensure that the released funds does not confer the sanction for incur the expenditure which shall be booked after observing all codal formalities.
