Subject: - Release of additional funds of State Capex Budget 2018-19 under Urban Development Sector- land acquisition of Bus Stand Katra thereof.

Sanction is hereby accorded to the release of additional funds amounting to **Rs. 10.00 Crore (Rupees Ten Crore)** only in favour of Deputy Commissioner, Reasi (District Collector) on account of Land compensation required for the Acquisition of land for "**Construction of New Bus Stand at Katra and its approach road via Village Kundrorian**", Tehsil Katra District Reasi under State Capex Budget 2018-19 of Urban Development Sector.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the shajra khasra of the land to be acquired shall be authenticated by the competent authority and as per the final award issued by the land collector;
- (ii) the cost of land to be acquired for the purpose shall be a part of project cost;
- (iii) all codal formalities are strictly adhered to while booking the expenditure and making the payment of compensation to the land owners;
- (iv) the funds so released shall not be available for any re-appropriation/diversion;
- (v) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (vi) it shall be incumbent upon the Deputy Commissioner, Reasi (District Collector) to ensure that the instant release of Rs. 10.00 Crore is further released only after the available Rs. 21.00 Crore is fully disbursed to the rightful claimants within 30 days positively;
- (vii) the implementing agency shall ensure that there is no overlapping of funds from any other source;
- (viii) there should be no expenditure on Revenue or Revenue like item, besides, the funds are not parked un-necessary;
- (ix) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (x) the expenditure shall commensurate with the physical progress achieved;

- (xi) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
