- xvii) the physical verification of the works be conducted by the Senior Officers hierarchy to ascertain ground existence, quality parameters and execution as per detailed estimates as well as benefit to the public;
- xviii) the physical and financial progress report shall be furnished to the Admin. Deptt. well in time;
- xix) no expenditure shall be incurred against revised cost which has not been approved by the competent authority.
