- Subject: - Procurement of Lake cleaning Machines for J&K Lake & Waterways Development Authority (LAWDA) to augment the machinery resources for conservation of Dal Nageen Lake and hiring of Lake cleaning machinery as an interim measure for the current year.

Sanction is hereby accorded to: -

- i. Procurement of the following lake cleaning machinery/equipment, for 4 basins of Dal-Nageen lake, through global tendering process:
 - a. Weed harvester along with barges – 8 (2 for each basin)
 - b. Skimmers – 8 (2 for each basin)
 - c. Amphibious Excavators – 8 (2 for each basin)
 - d. Tug boats – 12 (3 for each basin)
 - e. Barges – 24 (6 for each basin)
- ii. Hiring of the above mentioned machinery/equipment by LAWDA, upto March 2019, through an open, transparent process after fulfilling all codal formalities.

The Procurement/Hiring of Lake cleaning machinery/equipment is subject to following conditions: -

- i. the procurement shall be made through Global tendering processes after fulfilling all requisite codal formalities;
- ii. the machine/equipment so hired shall invariably conform to the technical specifications and standards.
- iii. the material supplied under the Contract shall be fully insured—against loss or damage incidental to manufacture or acquisition, transportation, storage, and delivery etc;
- iv. the material shall be inspected by third party inspection agency like Controlled Equipage Item List (CEIL)/ Quantitative Underwater Ecological Surveying Techniques (QUEST).
