Sanction is hereby accorded to the temporary appointment of Mst. Gulshan W/O Ghulam Hassan Sheikh R/O Shaheed Gunj Srinagar as safaiwalli under SRO-43/1994 in Srinagar Municipal Corporation in the pay scale of Rs. 4440-7440 + grade pay of Rs. 1300 in relaxation of upper age bar.

The appointee shall report to the Commissioner Srinagar Municipal Corporation within a period of 21 days from the date of issuance of this order. The appointee shall be allowed to join only after production of the following certificates in original:-

- i. Age and health Certificate.
- ii. Date of Birth Certificate.
- iii. Academic qualification certificate, if any.
- iv. Permanent Resident Certificate.
- v. Certificate from the General Manager DIC and Dy. Director Employment concerned to the effect that no loan under self-employment scheme has been taken by the appointee.

The appointee shall be initially on probation for a period of two years. If, on verification, the certificates(s) produced by the appointee prove to be fake or forged, the appointment shall be cancelled ab initio.

The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report about the verification of her character and antecedents is received from the IGP (CID), to whom a reference shall be made by the Commissioner SMC.


