- i. the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities, expenditure be restricted only within the cost approved by the competent authority after observing all codal formalities;
- ii. the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- iii. The implementing agency shall ensure that there is no overlapping of funds for the works being executed form any other source such as SDRF/State Plan/District Plan/CSS/BADP/Flagship programme or any other source;
- iv. the funds so released shall not be available for any re-appropriation/diversion;
- v. the expenditure shall commensurate with the physical progress achieved;
- vi. the implementing agency shall vouchsafe the utilization of funds as per codal procedure/guidelines;
- vii. the physical and financial progress report shall be furnished to the Admin. Deptt. well in time;
