conditions that:-

(iii) the vetted cost of each component/activity shall not exceed in any case and all the necessary clearances/approvals shall be sought from the Competent/Regulatory Authority before implementation of the scheme.

(iv) The funds shall be utilized after observing all codal procedures/formalities/guidelines of the World Bank/procedures as laid

down in the Project Appraisal Document (PAD).

(v) the implementing agency shall ensure that the reasonability of rates and complete the project within the approved cost only and there shall be no cost/time over run.



- (vi) the funds so released shall be utilized for the specified purpose as approved under World Ban frame work and by the Competent Authority and shall not be available for any re-appropriation/diversion.
- (vii) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (viii) the funds shall not be utilized on Revenue or Revenue like items.
- (ix) the Utilization Certificate of the amount is rendered to the concerned quarters within the stipulated time;
- the expenditure shall commensurate with the physical progress achieved;
- (xi) that all video graphic/photographic evidence of works both preexecution & post execution shall be maintained;
- (xii) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- (xiii) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority
