Subject:- Re-designation of Urban Development Agencies for Implementation of Urban Poverty Alleviation Programmes.

**Government Order No. 223 -HUD of 2013**  
**Dated: 13 -08-2013**

1. Sanction is hereby accorded to the:-

- i) re-designation of Urban Development Agency, Kashmir ( UDAK) and Jammu urban Development Agency (JUDA) as District Urban Development Agencies ( DUDA) for District Srinagar ( including Ganderbal) and District Urban Development Agency Jammu ( including Samba) as contained in Govt. Order No. 40-HUD/P&S of 1998 dated 01.01.1998 issued under endorsement No. HUD/P&S/PMIUPEP/96(10) dated 2.1.1998 with the similar constitutions, Bye-Laws and MOA as approved for other District Urban Development Agencies of the State;
- ii) dissolution of Governing Body of erstwhile JUDA/UDAK and reconstitution of the Governing Body of the DUDA Srinagar and DUDA Jammu as per the composition of DUDA's of the districts;
- iii) fixing the criteria of district domicile for any engagement/appointment in respect of DUDAs by direct/regularization or by promotion upto the level of APO beyond which a person belonging to any district but permanent resident of J&K State shall be eligible for appointment by direct, regularization or promotion as the case may be. However, this shall not be applicable to the persons who are already engaged provided they opt for permanent absorption in the DUDA's, where they are presently serving.
- iv) placing of all DUDAs under Administrative and Financial control of SUDA which shall be regulatory/competent authority for taking any kind of administrative decisions such as Transfer, Posting, Promotion and on any other related issue with the approval of Chairman SUDA/Governing Body;
- v) distribution/allocation of Community Organizers to the various DUDAs on the basis of population of Urban Poor in respective districts(s);
- vi) treating of all the employees of DUDAs, except who are on deputation from GAD/Planning/Finance, as temporary whose engagement shall be co-terminus with the Poverty Alleviation

Schemes sponsored by Govt. of India and implemented  
H&UDD.

2. The Project Officers of DUDAs shall be at liberty to seek any assistance from Executive Officers of the respective Municipal Committees/Councils as and when required for carrying out any special time bound assignment. The Executive Officers shall create Urban Poverty Alleviation Cells (UPA) in the respective Municipal Councils/Committees and deploy atleast two(2) persons within the existing staff for the Cell;
3. The DUDA Jammu and DUDA Srinagar shall continue to be Nodal DUDAs only for compiling progress reports and other information received from various DUDAs of respective provinces for submission to Administrative Department well in time. However, the DUDA's shall also endorse an advance copy to Admn. Deptt. invariably;
4. The wages of the daily-wagers/casual labours/ consolidated/ contractual appointees shall be debited to the UCDN/A&OE head of central plan assistance.
5. In case of matters/issues not specifically mentioned hereunder, the decision of SUDA shall be final.


