The above arrangement shall be subject to the condition that

- i) they shall work in their own pay and grade purely on stop gap arrangement against available vacancy till the posts are filled up on regular basis under rules or till alternative arrangements are made, whichever be earlier.
- ii) the temporary arrangement shall not confer any preferential right on them to claim promotion on substantive basis which shall be considered by the DPC as per rules and only if promotion quota so permits.
- iii) The arrangement will be without prejudice to the seniority and superior claim of others, if any and subject to the outcome of the writ petition(s), if any, pending before the competent Court of law.

All the transferees shall be deemed to have been relieved from their present places of posting with immediate effect.


